Rules of Engagement

- 1 Sever all sexual ties – be firm in your decision
- 2 Control your emotions at all times
- 3 Establish neutral child pick-up locations – absolutely no children are to be exchanged at either party personal location – baby momma or baby daddy's resident – PERIOD!
- 4 Follow all the rules of the court order – don't be vindictive
- 5 Don't have a court order – create visitation times by a written contract – both parties must date and sign the contract
- 6 Sever all future personal activities and family gatherings with the baby momma or the baby daddy to avoid arguments and conflicts
- 7 Child Support: All payments must be paid on time! If either party decides to make extra payments – all payments must be in the form of a money order – and the money order must be mailed with a certified return receipt. You should make a copy of the money order for your records. Please be advised – you will not receive credit for payments made outside of the court order.
- 8 Remember, no matter how many baby mothers or baby daddies each person has created – all children belong to the man's estate due to his DNA connection. Any person attempting to stop the biological father or mother from seeing his biological child will fail due to the physical and spiritual connection that cannot be severed by any person on earth.
- 9 Once a contract has been completed, if both parties discover specific terms and conditions need to be added – create an addendum to the contract and date and sign the document. Do not lie – cheat – or falsify the contract by adding a fake addendum to the contract. All signatures can be analyzed and verified by a handwriting expert in court.
- 10 Once the contract is complete – take the contract to an official state notary. This step completes the entire process, and it is now official.

The baby momma – baby daddy contract is designed to avoid future conflicts, chaos, arguments, and disappointments. It is designed to create a "Meeting of the Minds" of both parties. Remember, if you have multiple baby momma's or baby daddies, each one of them must enter a separate signed contract. This agreement is very important once a new person of interest enters the baby momma or baby daddy's life. A very important clause to be placed into the contract would be "no personal interference in each other love life."

You can use this template as a guide; however, it's very important to create your own. Please be specific to your lifestyle needs and wants when creating the contract. The power struggle between both the baby momma and the baby daddy can prove to be difficult and deadly.
