1. TERMS AND CONDITIONS OF THE RELATIONSHIP

Both parties agree to openly communicate expectations, boundaries, and needs on a regular basis. This contract establishes clear understanding of roles, responsibilities, and mutual respect within the household.

2. SEXUAL INTERACTIONS AND EXPECTATIONS

3. BENEFICIAL ENGAGEMENT WITH THE BABY MOMMA'S CHILDREN

The Stepfather agrees to engage with the children in a positive, supportive, and beneficial manner including: mentoring, guidance, emotional support, quality time activities, and being a positive male role model. The Stepfather understands this is a privilege that must be earned through consistent positive behavior and respect.

4. CLEAR UNDERSTANDING THAT THE CHILDREN ARE NOT HIS BIOLOGICALLY

The Stepfather acknowledges and accepts that the children have a biological father and that bond cannot and will not be replaced. The Stepfather agrees to respect the biological father's position, rights, and relationship with his children. The Stepfather's role is to support, not replace, the biological father.

7. STEPFATHER / STEPDAUGHTER INTERACTIONS - BOUNDARIES - DO'S AND DON'TS

CRITICAL BOUNDARIES FOR PROTECTION OF ALL PARTIES:

DO'S:

- Do treat stepdaughter with respect and appropriate fatherly guidance
- Do maintain proper physical boundaries at all times
- Do ensure Baby Momma is present during private conversations when possible
- Do support her education, goals, and personal development
- Do respect her privacy and personal space

DON'TS:

- DON'T engage in any inappropriate physical contact whatsoever
- DON'T be alone in private spaces (bedrooms, bathrooms) with stepdaughter
- DON'T make comments about her physical appearance or developing body
- DON'T engage in conversations of a sexual nature
- DON'T violate her privacy or personal boundaries
- DON'T attempt to replace her biological father

ZERO TOLERANCE POLICY: Any violation of these boundaries will result in immediate termination of this agreement and relationship, and may result in legal consequences.

8. STEPFATHER / STEPSON INTERACTIONS

The Stepfather agrees to mentor, guide, and support stepson(s) with appropriate masculine guidance, life skills, education support, and positive role modeling. Physical discipline must be discussed and agreed upon by both Baby Momma and Stepfather in advance.

9. DISCIPLINARY RULES

Note: The Baby Momma retains primary authority over all major disciplinary decisions. The Stepfather must consult Baby Momma before implementing any significant discipline.

10. COMMUNICATION AND CONFLICT RESOLUTION

Both parties agree to communicate respectfully, resolve conflicts peacefully, and seek counseling or mediation if needed. No yelling, name-calling, or verbal abuse in front of children. Disagreements will be handled privately between adults.

11. FINANCIAL RESPONSIBILITIES

Financial contributions and expectations:

Child support from biological father remains separate and is not to be influenced by this agreement.

12. RELATIONSHIP WITH BIOLOGICAL FATHER

The Stepfather agrees to respect and facilitate the biological father's relationship with his children. No interference with visitation, no negative comments about biological father in front of children, and cooperation with co-parenting arrangements. The children's relationship with their biological father is sacred and must be protected.

EXIT STRATEGY AND RELATIONSHIP TERMINATION

If this relationship ends, both parties agree to:

The Stepfather understands he has no legal rights to the children and must respect boundaries if the relationship terminates.

ADDITIONAL TERMS & CONDITIONS

IMPORTANT NOTE

This contract is designed to protect all parties involved – especially the children. Clear boundaries prevent misunderstandings, false accusations, and inappropriate behavior. The stepfather role is one of tremendous responsibility and must be taken seriously. The safety and well-being of the children is the highest priority. Both parties must honor this agreement with integrity and respect.
