TERMS AND CONDITIONS OF MARRIAGE

1. Mutual Respect & Honor: Both parties agree to treat each other with dignity, respect, and honor at all times. This includes speaking kindly to and about each other, acknowledging each other's contributions, and never humiliating, belittling, or disrespecting each other in public or private. Both parties will honor each other's feelings, opinions, and personal boundaries.

2. Fidelity & Commitment: Both parties pledge absolute faithfulness and loyalty to each other. This includes complete sexual fidelity, emotional faithfulness, and unwavering commitment to the marriage. Neither party will engage in romantic, sexual, or inappropriate emotional relationships with others. Both parties will avoid situations that could compromise the integrity of the marriage.

3. Financial Partnership & Responsibilities: Both parties agree to be transparent about all financial matters including income, expenses, debts, and assets. All major financial decisions will be made jointly. Both parties will contribute to the household according to their abilities and circumstances. A monthly financial meeting will be held to discuss budget, goals, and any concerns.

4. Household Duties & Shared Responsibilities: Both parties will share household responsibilities fairly and according to their schedules and abilities. This includes cooking, cleaning, maintenance, childcare (if applicable), and other domestic duties. Neither party will expect the other to carry the entire burden of household management. While honoring and respecting parents and family, both parties recognize that the marriage takes priority over extended family relationships. Neither party will allow family members to interfere with or damage the marriage relationship.

9. Personal Growth & Individual Development: Both parties commit to supporting each other's personal growth, education, career goals, and spiritual development. Each person will maintain their individual identity while growing together as a couple. Both parties will encourage and support each other's dreams and aspirations.

10. Health & Wellness: Both parties agree to take care of their physical, mental, and spiritual health. This includes maintaining personal hygiene, seeking medical care when needed, exercising regularly, eating healthy, and managing stress appropriately. Both parties will support each other's health and wellness goals.
